Agarwal, Former Professor of IIT-Kanpur and then Member Secretary of CPCB was instrumental to shift IAAPC from B.H.U to Delhi in the year 1983.

Prof. J.M. Dave, Professor & Dean of School of Environmental Science, J.N.U was nominated as President and Prof. H.B. Mathur, Professor Head Mechanical Engineering Department of IIT-Delhi was Secretary General. I was Secretary & Editor of IAAPC at that time.

In 1983 IAAPC organised the 1<sup>st</sup> activity with a series of lectures on Air Pollution Management (inventory, monitoring, modelling, prevention and control) by Prof. A.C. Stern, renowned international expert on Air Pollution Control at IIT Delhi. The series of lectures were attended by many students / faculty of IIT Delhi, CPCB and SPCB officials.

IAAPC under the leadership of Prof. J.M. Dave, Dr. G.D. Agarwal, Prof. H.B. Mathur with active support of Prof. Nilay Choudhuri, then Chairman of CPCB has initiated a number of technical work and some of the activities are as under:-

- Organised public meetings on Air Pollution Control to sensitise general people and students about the air pollution problem in the country.
- Provided scientific inputs on framing National Ambient Air Quality Standards.
- Scientific aspects of control air pollution due to stubble burning.
- Study the impact of air pollution on plants and vegetation.
- Study on impact of air pollution on human health.
- Options and strategy to control air pollution from NCR-Delhi region.
- VOC / HAP assessment and control from chemical industries.
- Organised training programmes on Air Quality Management for SPCB / CPCB officials.

- Views of Association on new areas of air pollution control measures like, Electric Vehicle policy, recycling of EV batteries, use of green hydrogen as fuel in industries for reduction of air pollution and GHG emission, clean technologies for pollution control from thermal power plants, steel plants etc.
- Provide suitable scientific views and suggestion to the NGT panel on various air pollution issues in the country.
- Give constructive comments and suggestions on technical decisions taken by SEIAA / EAC on various projects on air pollution management, based on Minutes of meeting available at public domain.
